Specific functions the candidate will have to carry out, teaching and scientific commitments: *Teaching activities*:

The candidate will have to carry out teaching activities within the Competition Sector 11/A5 DEMOLOGY, ETHNOLOGY AND ANTHROPOLOGY SCIENCES, Scientific Disciplinary Sector M-DEA/01 DEMOLOGY, ETHNOLOGY AND ANTHROPOLOGY. The required teaching commitment consists in carrying out cultural and social anthropology courses within the Department of Humanities, Social Sciences and Education (SUSeF) and, subordinately, other departments of the University, with particular reference to: Cultural Anthropology and heritage, Social Anthropology, Anthropology of care, Anthropology of Tourism and Anthropology applied to the field of social services and migrations. The teaching commitment also includes tutoring activities, assistance to students in drafting papers for the final exam of the degree courses, for masterdegree theses and for doctoral theses. Particular attention must be paid to ongoing and entry-level educational orientation, internationalization and the third mission.

Research activities:

The candidate must have the ability to carry out research activities within the Competition Sector 11/A5 DEMOLOGY, ETHNOLOGY AND ANTHROPOLOGY SCIENCES, Scientific Disciplinary Sector M-DEA/01 DEMOLOGY, ETHNOLOGY AND ANTHROPOLOGY and consistent with the strategic objectives of the University and the Department of Sciences Humanities, Social Sciences and Education(SUSeF). In particular, research activity must be concentrated around the anthropology of cultural and environmental heritage, of the knowledge and practices of internal areas and of rural societies in transition with particular reference to the processes of safeguarding and valorising intangible cultural heritage, to the processes of regeneration and sustainable development of fragile communities in rural and mountain regions.
